TERMS

ENTIRE AGREEMENT

These terms and conditions along with the terms and conditions on Suburban Lumber Company's (hereinafter referred to as Seller) invoice and delivery ticket which are incorporated by reference (together referred to as "TERMS") represent the entire agreement between the parties. No other terms, including those on Applicant's Purchase Order, which are different may add to, modify, supersede or otherwise alter the TERMS without express written approval signed by an authorized representative of Seller. All other terms are herby rejected.

PAYMENT

Applicant agrees to pay for the product according to the TERMS. If the applicant fails to make any payment to Seller when due, Applicant's entire account(s) with Seller shall become immediately due and payable without notice or demand. All past due amounts are subject to a service charge of 1.5% per month or, at Seller's option, up to the maximum rate permitted by law. Applicant does hereby grant Seller a security interest in the products until such time as Seller is fully paid. Applicant will assist Seller in taking the necessary action to perfect and protect Seller's security interest. If Applicant is in default for non-payment and the account is placed with a third party for collection, Applicant agrees to pay all costs including reasonable attorney fees, collection costs, court costs, and finance charges. Applicant also agrees that in the event either party pursues legal action that the proper place of jurisdiction will be Cedar Rapids, Linn County, Iowa, and further that the laws of the State of Iowa will be applicable.

TERMS OF SALE

Payment in full by check, cash or cash equivalent shall be due on the 10th day of the month following purchase. Payment on account by credit card or debit card is not allowed.

CERTIFICATION

The applicant certifies the following: (1) the information I provided is true and correct and has been submitted to obtain commercial credit; (2) I am authorized to execute application and other document required to establish commercial credit accounts on behalf of the Applicant; (3) Seller is hereby authorized to investigate and verify any information provided and inquire of references or others as to credit worthiness; (4) Seller may answer questions from others about its credit experience with the Applicant; and (5) I have read, understood, and agreed to all of the TERMS, and agree to notify Suburban Lumber Company, in writing, of any material change in ownership within five days.

The Guarantor hereby agrees to the extent permitted by law, to waive the Homestead exemption, notice of acceptance, notice of presentment, demand, non-payment, dishonor and protest. Furthermore, Guarantor consents to and waives notice of any modification, amendment of extension of the terms of credit agreement hereby guaranteed. Grantor hereby authorizes Suburban Lumber Company to obtain and use Credit Reports from time to time on the Guarantor for the sole purpose of evaluating current and ongoing credit worthiness in connection with the extension of business credit as contemplated by this credit applicant.
